

# Linden Sportsmen Club 2011 NRA Style High Power Sporting Rifle Trial Match

**Date:** September 4

**Location:** Linden Sportsmen Club 14343 Hogan Rd. Linden, MI 48451 (Go west ½ mile on Silver Lake Rd. to Hogan Rd. Turn right and go ½ mile north to club grounds.)

**Rules:** Current NRA rules will govern.

**Eligibility:** NRA Rule 1.7c This is an Open Match

**Safety:** NRA open bolt indicator flags are required. They will be available for purchase at the match.  
EYE AND HEARING PROTECTION ARE MANDATORY.  
RIFLES MUST NOT BE ELEVATED ABOVE THE BACK STOP AT ANY TIME!!!

**Entries:** Match is limited to 57 competitors.

**Range:** All firing will be done at 100 yards.

**Entries Close:** The morning of each match.

**Squadding:** The matches will be squadded at registration and squadding will close at 8:30am

**Fees:** All Adult entry fee \$15.00 includes Target Fee, and Awards.

Junior entry fee \$5.00 includes Target Fee and no awards

**Time of Firing:** The Match will commence at 9:00 am.

**Rifle Allowed:** Any center fire rifle and any sight allowed. Rifle with scope and empty magazine with sling removed shall not weigh more than 9.5 pounds. No Muzzle Breaks allowed. Five sight in shots in any position will be allowed at the beginning. Total of 37 rounds fired.

**Equipment Not Allowed:** Specialized shooting gloves/mitts, competitive shooting coats, palm rest, Schuetzen butt plate, or shooting cuff style slings.

**Equipment Allowed:** Spotting scope, shooting kit/stool, ground cloth/pad, elbow pads, slings or any material and style as used for hunting/military rifles.

**Course of Fire: (sustained fire will be fired as two strings of 4 shots from position.30 seconds per string )**

**Match 1** 8 Shots for Record, time limit 8 minutes, SR-1 target Offhand Position

**Match 2** 8 Shots for Record, time limit 30 Seconds, SR-1 Target Sitting or Kneeling.

**Match 3** 8 Shots for Record, time limit 30 Seconds, SR-1 Target Prone Position

**Match 4** 8 Shots for Record, time limit 8 minutes, SR-1 Target Prone Slow fire

**Match 5** Grand Aggregate of Matches 1 thru 4.

**Award Disposition:** Class awards will be given on matches 1,2,3,4, & 5. Juniors will not receive cash awards.

## Notes to Competitors:

### 1. No Re-Fire Rule in effect NRA 9.12

Exception: Additional time will be allowed for Marksman and Unclassified Shooters only, while the match personnel feel it is important for these competitors to get their rounds off they need not rush to accomplish that task.
